

Disposition of Additional State Subsidy²: The voters of the Regional School Unit have authorized the School Board to use all or part of additional state subsidy received, if any, to decrease the local cost share expectation, as defined in Title 20A, section 15671A(1)(B), for local property taxpayers for funding public education as approved by the School Board.


²Under authority of the School Board, the Superintendent of Schools must strike the statement concerning Disposition of Additional State Subsidy if the voters did not so authorize.
